

## 2025-2026 Verification Worksheet Dependent Student

Your 2025-2026 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. The law says that before awarding Federal Student Aid, we may ask you to confirm the information you reported on your FAFSA. To verify that you provided correct information the financial aid administrator at your school will compare your FAFSA with the information on this worksheet and with any other required documents. If there are differences, your FAFSA information may need to be corrected. You must complete and sign this worksheet, attach any required documents, and submit the form and other required documents to the financial aid administrator at your school. Your school may ask for additional information. If you have questions about verification, contact your financial aid administrator as soon as possible so that your financial aid will not be delayed.

### B. Verification of Identity (***complete in person at the institution***)

- **The student must appear in person at Southeastern Community College** to verify his or her identity by presenting an unexpired valid government-issued photo identification (ID), such as, but not limited to, a driver's license, other state-issued ID, or passport. The institution will maintain a copy of the student's photo ID that is annotated by the institution with the date it was received and reviewed, and the name of the official at the institution authorized to receive and review the student's ID.

### C. Verification of Identity (if unable to appear in person)

If the student is unable to appear in person at Southeastern Community College to verify his or her identity, the student must provide to the institution:

- o A copy of the unexpired valid government-issued photo identification (ID) that is acknowledged and presented to a notary, such as, but not limited to, a driver's license, other state-issued ID, or passport.
