Bids will be publicly opened and read aloud after 1:30 P.M. in the Boardroom, 1500 West Agency Road, West Burlington, Iowa 52655.

Consideration of the bids received and the award of contracts or other action may be made by the Board of Trustees of the Southeastern Community College upon the proposals received in accordance with the law and the plans and specifications at its regular meeting anticipated at 4:30 P.M. on Monday, April 8, 2024, in the Boardroom, located at 1500 West Agency Road, West Burlington, lowa 52655.

The Project consists of general site improvements at the West Burlington, Iowa, campus including: ~10,868 SF of 7" PCC pavement with 6" aggregate base course, geofabric, and associated pavement markings, 1,179 SF of 4" PCC pavement with 6" aggregate base course, and minor landscape work including turf reinforcement mat and erosion control measures. An Additive Alternate will be included at a per linear foot rate based on available funding, including: ~24 LF width of 7" PCC pavement with 6" aggregate base course, geofabric, and associated pavement markings, and minor landscape work including erosion control measures.

Work on the Project shall commence on May 13, 2024 and shall be substantially complete by June 29, 2024. Base bids must be a lump sum basis for a single Combined Construction Contract as described in the specifications with an Additive Alternate.
